Dear Friend-

July was a busy month with candidate forums, and doorbelling for our conservative non-partisan candidates who were mostly running for City Council positions. Even though they were not running as Republicans and therefore could not be endorsed by the party, we could figure out who was who.

For the first time in my memory, I saw yard signs for non-partisan candidates with the word "Democrat" on them as well as on their doorbelling literature. Do they not understand the word "non-partisan" means not biased toward any particular political group? Therefore, it became easy for us to figure out who not to vote for. Then when we checked out their campaign websites, it further delineated where they leaned politically when all of their endorsements were Democrat organizations and public sector unions.

The other difficulty in this primary election was that every city had a different set of people who were up for election. Then there was Seattle, which had 7 different ballots based on 7 City Council Districts. We counted at least 40 different ballots in this election.

Several conservative groups sent out their picks, and we answered questions about the "best" candidates via phone calls, text messages and Facebook. If you ever have questions about how to vote or for whom to vote, please contact KCGOP.

Hope to see all of you on October 25th!




