Dear Friends,

Who would have guessed we would end the month of May and start this month going from one devastating situation to another? The riots came just as we were seeing the prospect of our lives soon returning to near normal in King County. Then many of our members saw their months of sacrifice tossed aside by lawless mobs taking advantage of an opportunity to loot and destroy property. People anticipating going back to work and opening their businesses saw their hopes dashed like so much broken glass.

There was a glimmer of hope in the past few weeks when both sides came together to condemn the tragic death of George Floyd. This moment of unity was ruined when the left began accusing our police as being the cause of peaceful protests turning into riots. Those who supported the peaceful protests, yet not the violence, were also condemned.

The Bill of Rights states that it is the right of the people to peaceably assemble. Non-violent protests are protected speech under our constitution. Yet the lawlessness and destructive chaos we are witnessing is not protected speech, should not be tolerated, and does nothing to serve the purported purpose of combating racism. 


